

Notice of 2020 Primary Election

Notice is hereby given that on Tuesday, the 12th of May, 2020 at the usual polling places in the precincts of Adams County, Nebraska an election will be held. The polls will open at 8:00 a.m. and will close at 8:00 p.m. CST. Said election will be for nominating candidates to various offices. The Secretary of State will publish a true copy of the title and text of any amendment or referendums once each week for three consecutive weeks preceding the election. *Pursuant to §32-811, some partisan and nonpartisan races will not appear on the Primary Election. If the names of candidates properly filed for nomination at the Primary Election do not exceed twice the number of vacancies; Partisan Office races when only one filing is received and no write-in affidavit is received by March 1; any such candidates shall be declared nominated and their names shall not appear on the Primary Election ballots. The official Abstract of Votes for the Primary Election shall show the names of such candidates as NOMINATED WITHOUT OPPOSITION and their names will automatically advance to the General Election ballot.*

Special Issues

Hastings Public Schools (SD 0018) Bond Issue

“Shall Adams County School District 0018 (Hastings Public Schools) in the State of Nebraska issue its general obligation bonds in an aggregate stated principal amount not to exceed Six Million Dollars (\$6,000,000.00), for the purpose of paying costs of improvements to existing facilities of the District, which may include improvements at Morton Elementary School and other District facilities; such bonds to be issued from time to time, to bear interest at such rate or rates, to be sold at such prices and to become due at such time or times as may be fixed by, or determined at the direction of, the Board of Education; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of and interest on such bonds as the same become due?”

Village of Juniata – Sales Tax Issue

Shall the Board of Trustees of the Village of Juniata, Nebraska, impose a sales and use tax of an additional amount of one half percent (1/2%) upon transactions within the Village of Juniata on which the State of Nebraska is authorized to impose a tax, with the revenue collected therefore to be used for Village street repairs and street improvements?
