**Salary for the Adams County Public Defender

WHEREAS, Nebraska Revised §23-1114 states:

- (1) The salaries of all elected officers of the county shall be fixed by the county board prior to January 15 of the year in which a general election will be held for the respective offices. And

WHEREAS, the Adams County Board of Supervisors intends to abide by the statutory requirement. And

WHEREAS, the position of the Adams County Public Defender will be on the 2016 election ballot, therefore

BE IT RESOLVED that the Adams County Board fixes the annual salary of the Adams County Public Defender as follows:

BE IT FURTHER RESOLVED that as stated in Adams County Resolutions 74-13 and 76-1-6, the position of the Adams County Public Defender is considered an exempt part time position, and the person holding his office may engage in the private practice of law. Reimbursable office expenses, if any, shall be reviewed each year at the annual budget hearings for the County.

BE IT FURTHER RESOLVED that in addition to the above stated salary, the Adams County Public Defender shall be entitled to all benefits offered to full time Adams County employees.

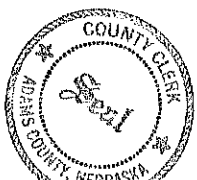


