It is further understood and agreed that said Grantee agrees to replace the surface of the roadways which were disturbed in construction or maintenance of the said driveway entrance, and to leave said roadway in as good a condition as existed immediately prior to the installation or maintenance of said driveway entrance. Approval of the road to be given after the construction and or maintenance of the driveway entrance by the County Highway Superintendent, Assistant Highway Superintendent, or County Road Foreman.

The Grantee hereby covenants and agrees to hold himself liable for all or any liability, injury, loss, damage or expense suffered by any and all persons and or property during the period of construction and or maintenance.

Grantee also agrees to build driveway entrance with size of drainage culvert as specified by Adams County and also culvert will meet Adams County specifications. <u>Culverts smaller than 18" in diameter will not be permitted, unless otherwise approved.</u>

Grantee also agrees to purchase culvert, gravel and earth materials required for construction of the driveway at their own expense.

GRANTEE WILL BE RESPONSIBLE FOR SIGNAGE AND BARRICADES AND SHALL FOLLOW THE REGULATIONS OF THE LATEST MUTCD MANUAL. ADAMS COUNTY WILL NOT PROVIDE SIGNS OR BARRICADES.

Grantee may hire Adams County Highway Department to construct said driveway up to 40' in length and remit payment in consideration of Three-hundred Dollars (\$300.00) to the County, paid by Grantee, for the costs incurred by said county in the construction of said driveway. Fee does not include costs for culvert.
