March 17, 2024

VEHICLE #1 WENT OFF THE ROADWAY NORTH OF THE INTERSECTION AND STRUCK A STOP SIGN SUPPORT (KNOCKING OVER THE STOP SIGN). AFTER STRIKING THE STOP SIGN, VEHICLE # 1 STRUCK A DITCH EMBANKMENT. DAMAGE WAS OBSERVED ON THE FRONT END AND UNDERCARRIAGE OF VEHICLE # 1.
